General Guidelines

- (1) All admissions are provisional. Students will be admitted only on the basis of submission of various supporting documents as listed below.
- (2) Students who fail to produce necessary supporting documents as per their Application Form will not be admitted and their seats will be transferred to other eligible candidates in the second round.
- (3) In respect of admissions, the decisions of the Admission Committees of the respective Training Centres, viz., SIAC, PITCs, YASHADA, BARTI, PCMC, CDIAC and UPSCCETC will be final and binding.

Guidelines for the Second & Final Merit List

- (a) Students whose names have appeared in the First List should secure their admissions as per the above schedule, failing which their claim to admission will be forfeited and their seats will be transferred to other eligible candidates as per the merit in the Second Merit List.
- (b) Those students who fail to seek admission as per the above schedule to the centre allotted to them in the First List will lose their claim at that centre and they will be considered for admissions to the remaining centres as per their preference in the Second Round.
- (c) After the Second Round, each training institution will announce their vacant seats and students will have to make direct applications to the centres of their choice as per the availability of the seats.

- (2) Non-SC & Non-ST Reserved Category Candidates will have to submit Non-creamy Layer Certificate (NCL) valid till March, 2023.
- (3) At SIAC & PITCs, 5% of the seats are reserved in the respective category for the candidates belonging to Maharashtra Karnataka Disputed (MKD) Border Region.
- (4) Candidates seeking admission at SPA, PCMC will have to submit ANY ONE documentary proof from Ration Card, Passport, Driving License, Property Tax Payment Receipt of the Property in PCMC Region, Aadhar Card, Election Card or Electricity Bill in his/her or parents name for establishing their residential status within PCMC Region.
